## **Summary of Activities and Future Plans**

Since receiving my PhD in September 2015, I have devoted my academic work to combining two domains: criminal law and alternative dispute resolution.

In 2004-5, I successfully completed an internship at the State Attorney's Office. Upon my certification as a lawyer, I began working at a private law firm (Y. Dauber). During that period, which included court litigation, witness interrogation etc., I was exposed to the various aspects of hands-on legal work. I was especially interested in resolving conflicts outside the court. To enrich my practical and theoretical knowledge, I started a research-oriented M.A. in conflict resolution management and negotiation (CRMN) at Bar-Ilan University.

During my M.A (2010-2012), after achieving the highest grades in my class, I was offered to start a fully funded PhD degree for outstanding M.A students (BIU President Grant). My research was conducted under the supervision of Prof. Rachel Ben Ari of the School of Psychology. In this research, we developed a new and advanced model that predicts the behavior of individuals in conflicts when their justice perception is known. The research included an experimental aspect that validated our theoretical hypotheses.

At present, I am working as a senior lecturer at the Yezreel Valley College. My courses focus on criminal law and its alternatives, such as restorative justice, community courts, and mediation. They also deal with legal and psychological aspects of conflict resolution. My research topics combine criminal law and various psychological aspects such as alternative methods for settling criminal disputes, restorative justice, emotions and emotion regulation in courtroom and sexual offences.

In addition, I am conducting two main research projects with Dr. Dana Weimann Saks and the Israel Prison Service on the innovative concept of restorative justice procedures among inmates. In the same vein, I am conducting a research project on the influence of various psychological variables on the positions of members of the public, offenders and victims regarding punishment and punitive alternatives. This project is conducted in collaboration with Dr. Weimann Saks and Prof. Eran Halperin, a full professor of psychology at the Hebrew University of Jerusalem. Products from these projects have been published in highly reputable journals.

Moreover, a research proposal in this field has been accepted and funded by the ISF foundation. In the proposed research, we intend to conduct six experimental studies to examine the hypothesis that malleability beliefs play an essential psychological role in

shaping attitudes toward restorative justice (RJ) among the parties to the process (offenders, victims, and community members), and even in predicting the effectiveness of RJ practices. Additionally, the proposed research seeks to reveal the mechanism underlying the effect of belief in malleability on attitudes toward RJ, and the effectiveness of RJ practices, by examining the mediating effect of distinct emotions and possible boundary conditions.

Concurrently with these studies, over the past few years I have been collaborating with the Research Department of Association of Rape Crisis Centers in Israel and its General Director Dr. Carmit Klar-Chalamish. As part of this collaboration, I advise on studies conducted by the association and conduct joint studies on sexual abuse, victim's needs and alternative ways of coping with sexual victimization. Various studies I have written on this topic have been published in leading international journals as well as in Hebrew books.

In recent years, my professional efforts have also included significant contributions to the community, I delivered lectures to school-aged children in my local community, aiming to introduce them to the world of research and foster their curiosity about academic inquiry. In 2022, I supported and advised educators at Kadoorie High School in Lower Galilee in developing a criminology program, which included designing the curriculum and preparing it for submission to the Ministry of Education. Additionally, between 2022 and 2023, I conducted lectures for various groups of soldiers during academic orientation days, encouraging them to pursue higher education following their military service. From 2024 onward, I have served as a mentor for high school students conducting independent research projects as part of their 5-unit matriculation requirements, providing this guidance voluntarily.
